YEAR IN REVIEW 2024/2025



Chairs note

HASANZ recognises and honours those who have lost their lives or suffered serious harm at work over the past year. Despite nearly 15 years since the Pike River Mine disaster, workplace fatalities and injuries persist in New Zealand. HASANZ remains committed to advocating for better health and safety outcomes across Aotearoa New Zealand.

We believe that meaningful progress in health and safety is achievable when competent professionals are heard by the government and businesses. These experts are essential in creating quality and fit for purpose legislation as well as helping businesses understand and manage workplace risks, drive prevention efforts, implement effective controls, and create safer working environments.

HASANZ works closely with our member associations to promote high standards for health and safety professionals, urging businesses to seek guidance from properly trained and accredited individuals. Supporting and empowering these professionals through ongoing development and recognition is crucial. Our advocacy strengthens the health and safety ecosystem, ensuring better outcomes for everyone.

In the past financial year to March 2025, HASANZ successfully completed multiple projects and initiated planning for future endeavours. The Scholarship and Register programmes have reached unprecedented levels of success, while the GM Safety and HS Education Forums have made significant advancements, further extending HASANZ's influence.

Education

In 2024, we celebrated a milestone with the 145th HASANZ, Health and Safety Scholarship. This programme supports individuals requiring financial assistance to study and conduct research in this field. In partnership with Trevelyan, HASANZ initiated a pilot project targeting a specific industry and region, resulting in the award of six scholarships. Notably, one was the first-ever awarded to a farmer. We aim for the success of this pilot to help us provide more industry-specific awards in the future.

Field Days have been revived! After a hiatus since COVID, HASANZ hosted its first in-person field days, providing an engaging platform for sponsors, recipients, and leaders in health and safety to connect, learn, and share.

Alongside its support for individuals, HASANZ has collaborated with specialist organisations to deliver unique training opportunities. Women in Safety Excellence (WISE) partnered with HASANZ to provide strategic leadership training for 24 women who either hold or aspire to hold leadership roles. Additionally, The Law Association worked with HASANZ to host New Zealand's inaugural health and safety expert witness training, aimed at helping leaders further develop their expertise and promoting greater professionalism in health and safety within the legal sector.

















HASANZ Register

The revitalised HASANZ Register gained significant traction in 2024, witnessing a remarkable increase in the number of individuals becoming HASANZ Registered Professionals. All HASANZ Registered Professionals are competent, certified, and qualified. As awareness of the importance of hiring skilled and qualified professionals has grown, the HASANZ Register is being increasingly seen as a vital resource for Aotearoa New Zealand's health and safety sector.

In the five years since its launch, the number of HASANZ Registered Professionals has reached an unprecedented high, accompanied by a rise in searches for these professionals.

Workforce Development

HASANZ completed its WorkSafe-funded workforce development projects with key associations, including NZ Occupational Health Nurses Association, New Zealand Occupational Hygiene Society, Human Factors and Ergonomics Society New Zealand, and in Hazardous Substances. Best practices and insights will be compiled in the coming months to provide guidance and resources for other disciplines.

Following the hazardous substances project, HASANZ continues to deliver online training modules covering Flammable Gases and Liquids (Classes 2 and 3), Oxidising Substances (Class 5), Toxic and Corrosive Substances (Classes 6 and 8), and Stationary Containers. Building a sustainable, qualified compliance certifier workforce remains a priority.

Conference

The HASANZ Biennial Conference united health and safety professionals in Wellington, fostering collaboration and connection. Organised by industry experts, the event explored critical topics in health and safety, featuring engaging presentations from international and local speakers that tackled the latest challenges and trends. Participants included business leaders, educators, health and safety professionals, and policymakers, all of whom joined lively discussions and knowledge sharing. Feedback indicated that participants valued both the networking opportunities and the engaging, high-quality content.

The HASANZ Conference was only possible with the contribution of all of our sponsors especially our Conference partner ACC. We also appreciate all the fabulous keynote speakers, presenters, exhibitors, delegates, and volunteers who made this Conference a success.

Current position and the future

This financial year has presented several challenges. HASANZ has encountered difficulties due to reduced public spending, which has led to a significant loss of funding from WorkSafe NZ and collaborative projects with other publicly funded organizations. Furthermore, the tough economic landscape has limited opportunities in the private sector.

Despite these challenges, HASANZ is fortunate to have forged a strong partnership with ACC, which empowers us to continue being a key player in Aotearoa New Zealand's health and safety ecosystem. We are confident that our upcoming projects will secure the essential resources needed to support our vital work and deliver additional benefits to the ecosystem in a more sustainable manner.
