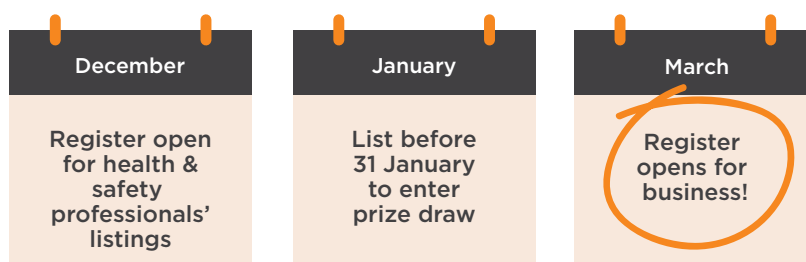
A PROGRESS UPDATE ON THE HASANZ REGISTER OF WORKPLACE HEALTH AND SAFETY PROFESSIONALS

THE HASANZ REGISTER IS OPEN FOR LISTING

The HASANZ Register is now open for listing. The HASANZ Register is a national, online database to help businesses find qualified workplace health and safety professionals. Everyone listed on the HASANZ Register must belong to a HASANZ member association and meet required competency standards, so businesses can have confidence in their advice and services. There's a charge to list on the register but it's free to use.

The HASANZ Register opens for business in March 2018.

It gives me great pleasure to announce that the HASANZ Register is now open for listing. I urge you to act now and make the most of our summer break to collate the documentation you need to apply. HASANZ will reward you for your efforts with our 'Be on to Win' competition, not to mention the new business you stand to gain by being seen on New Zealand's first register of workplace health and safety professionals.

The HASANZ Register has been tested extensively by expert external agencies, and also by representatives from HASANZ

member associations, to ensure it is secure and user friendly. The Register has been designed from the point of view of the businesses that are going to use it, but we've also tried to make it as easy as possible for health and safety professionals to create a profile with relevant information, reach and impact.

We're now ready to load the supply side of the market with a view to going live for the demand side of the market in March, once we have a minimum of 130 professionals listed. Help is on hand from your [HASANZ Register ambassadors](#). There's at least one from each member association. Please make them your first point of contact for enquiries about your association's registration standards - the minimum professional standards you must meet to be on the HASANZ Register. Get on board!

THE HASANZ-REGISTERED QUALITY MARK



The HASANZ-Registered quality mark is a unique identifier for health and safety professionals who are listed on the HASANZ Register. Like real estate agents or licensed building practitioners, it's the individual who is registered and only the individual who has earned the right to use the HASANZ-Registered quality mark on their business card and marketing material. The HASANZ-Registered quality mark and brand guidelines for using it will be sent to people listed on the Register when it opens for business.

GET FIT TO LIST



Take these 10 steps to list on the HASANZ Register:

1. Check you meet the registration standards for your member association.
2. Gather the required evidence documents to support your application.
3. Go to www.register.hasanz.org.nz
4. Create a HASANZ Register account.
5. Complete the online application form.
6. Submit your application for approval.
7. Pay the required fees using the online link.
8. Application assessed by your member association and HASANZ. They may ask you to provide more information.
9. Once your application is approved, HASANZ will email you a letter confirming approval.
10. HASANZ will make your profile public when the Register opens for business and send you a registration pack, including your certificate of registration.

“The Register will give business confidence that the health and safety professionals who are listed will be individuals who have challenged themselves to develop their capabilities and have had those capabilities tested and acknowledged as meeting appropriate standards. In addition, business owners will also know the services will be provided with integrity and professionalism as the provider has committed to upholding a code of professional ethics.”
